1. Applicants for membership must be sponsored by a regular member and recommended by at least three (3) members, regular or associate, who shall know the qualifications of and be able to endorse the applicant.
2. Application must be made on the prescribed form and accompanied by payment of the full annual dues. The sponsor will insure that the application is completely filled out, including, among other items, the date, the applicant's signature and appropriate recommendation signatures; the sponsor will also insure that the appropriate fee is paid and that the applicant receives a receipt from the receipt book. The application shall be forwarded to the committee. The sponsor will ensure that the application is legible.
3. Sponsors will consider it their duty, from the time proposed members' applications are completed until final action is taken by the Board of Governors, to keep the applicants interested in the Club and invite them to all Club activities during this interim period.
4. The receipt for payment will be used as temporary membership card until the applicant is voted in. Each application will be presented at two Board Meetings before being accepted.

Regular Membership . To qualify for Regular Membership, an individual must have a positive and actual interest in aviation. The member is required to pay dues, as set out in Article IX, any other fees as set by the Board of Governors, is entitled to hold office and has voting privileges. Persons qualifying under this category are those:

- Who hold an FAA license including A&P, ATC, etc.
- Who have soloed in an airplane, helicopter, hot air balloon, etc.
- Who are involved in military or commercial aviation on flight status.
- Who hold the military equivalent of A&P, ATC, etc.
- Who have completed at least three jumps (parachutists/sky divers)
- Who own aircraft, even if not licensed pilots
- Who are employed by aviation-connected entities, e.g., airlines, airports, FAA, fixed-base operators, etc.

Associate Membership. Any individual who does not qualify for regular membership but who meets the general qualifications stated in Sec. 1 may qualify for Associate Membership. When the associate member meets the qualifications of regular membership, a request may be made for upgrade to regular membership. This request must be approved by the Board of Governors. Associate members have all of the rights and privileges of regular membership except the right to hold office and vote.
